

SCRIPTS SUBMISSION TERMS AND CONDITIONS

In connection with Your registration and application for review and critique of Your Script, the following terms and conditions constitute an agreement between You and Dubai Film and Televisions Commission, (“DFTC, Commission,” “We” or “Us”). You understand and acknowledge that our evaluation of the Script may be negative or non-complimentary. You acknowledge and agree that You will not submit any Script that: (i) infringes, misappropriates or violates the intellectual property, publicity, privacy or other proprietary rights of any third party; (ii) harasses or advocates harassment of a third party; or (iii) which is threatening, obscene, defamatory, libelous, unlawful or promotes or encourages illegal activity.

1. You understands that the Commission would refuse to accept and evaluate the SCRIPT in the absence of Your acceptance of each and all of the provisions of this Script Submission Terms and Conditions (“Agreement”). You agree that You will not be entitled to any compensation of whatsoever nature resulting from the review, evaluation or use by the Commission of Your SCRIPT or material. You understand that the Commission is under no obligation to read and evaluate the SCRIPT.
2. You acknowledges that You are submitting the SCRIPT voluntarily, on an unsolicited basis, and not in confidence, and that no confidential, fiduciary or any other relationship whatsoever is intended or created between You and the Commission by the submission of the SCRIPT. You are solely responsible for protecting Your rights in the Script, including without limitation, for filing or registering the Script with any relevant authorities applicable to Your Copyright or Trademark over the SCRIPT.
3. You hereby represent and warrant the following:
 - You are the exclusive owner and sole author of the Script, such that the Script is Your original creative work and Your submission thereof will not infringe, misappropriate or violate the intellectual property, privacy or other rights of any third party; and/or You have obtained prior written authorization to act on behalf of any co-creators of the Script;
 - There are no threatened, pending or current claims, actions or lawsuits in connection with the Script and You agree to notify the Commission immediate upon Your notification of any such claims, actions or suits;
 - You are submitting the Script voluntarily on a non-confidential basis and no confidential relationship is intended or created between us by the submission of the Script;
 - You are at least eighteen (18) years of age; and
 - You have the right, authority, and capacity to enter into this terms and conditions, and You agree to abide and be bound the terms and conditions herein.
4. By submitting Your Script for review, the Commission/WE in no way grant You any additional rights therein or otherwise expand the scope of Your rights under applicable copyright laws. You are solely responsible for protecting Your rights in the Script, including without limitation for filing or registering the Script with the Copyright Office.
5. The Commission may at any time reserves the right to request for further documents for verification /authentication purposes. The Commission, at any time may request amendment on the SCRIPT or resubmission of the Script within a specified period as it deemed necessary. If You do not wish to proceed with Script review, Your only remedy is to cancel the Script submission; the Commission is under no obligation to return/destroy copies of the Script.. (
6. In case of any change in the content of the approved Script, You shall notify the Commission in writing and obtain approval from the Commission prior to any implementation of any such amendment.
7. Subject to the Your full compliance of the requirements of the Commission (including but not limited to submitting a request for filming permit, payment of fees, fulfillment of any other requirements, information, documents as the Commission deemed so require), You shall not carry on (or purport to carry on) any filming activity outside the emirate of Dubai solely on the basis of the Script approval granted by the Commission. You shall solely responsible to comply with all other applicable laws, regulations and rules

imposed by other regulatory body in conducting Your filming activity outside the emirate Dubai. The approval granted by the Commission is limited for Dubai use only.

8. The Commission shall not be liable for any loss/damage resulting from any delay in the approval, rejection or cancelation, revocation due to system error, malicious or unwanted software or for any acts of whatever nature including but not limited to regulatory restrictions, malicious contents, misrepresentation of the expected content and the like.
9. You acknowledge and agree that Commission/WE may seek independent consultant or third party review of the Script. In the event We forward Your Script to third parties, that Commission/WE hereby expressly waive any and all liability for any violation of Your intellectual property or other rights by any such third party, and You hereby release that Commission from any and all liabilities arising out of or related to our forwarding of the Script. However, You retain all rights to the Script itself.
10. You hereby consent to our use of your full name in connection with the Script via any media now known or later developed, for promotional, marketing or any other purposes WE deem appropriate, in our sole discretion. You acknowledge and agree that You will not be entitled to any compensation.
11. IN NO EVENT SHALL WE BE LIABLE TO YOU (OR TO ANY THIRD PARTY CLAIMING UNDER OR THROUGH YOU) FOR ANY INDIRECT, SPECIAL, INCIDENTAL, CONSEQUENTIAL OR EXEMPLARY DAMAGES RELATED TO YOUR SCRIPT EVEN IF WE KNEW OR SHOULD HAVE KNOWN OF THE POSSIBILITY OF SUCH DAMAGES.
12. You agree to defend, indemnify, and hold harmless the Commission, its employees, members, agents and affiliates from any and all liabilities, claims, demands and expenses, including attorney's fees, made by any third party that may be asserted against the Commission, at any time, in connection with the SCRIPT or any use thereof, including without limitation those arising from any breach of the warranties and promises provided herein.
13. You expressly waives any claim for express or implied breach of contract with respect to the SCRIPT, and You expressly waives any other claim of any kind or nature whatsoever with respect to any unprotected SCRIPT. You hereby releases, discharges, and holds the Commission harmless from any and all such claims, whether at law or in equity.
14. The Commission may at any time with or without any reason at all cancel the review or suspend and place the approvals of Your Script on hold. In such event, the Commission will not render and You are not entitled to receive a refund of any fees or portion thereof paid to the Commission in connection with the Script. The Commission shall not be liable to You or any third party for any such cancellation or revocation. You may withdraw Your application for Script review at any time provided however, that voluntary termination shall in no way relieve You of your responsibility to remit payment for all fees associated or entitle You to a refund of any other payments remitted to the Commission.
15. Our failure to enforce any of our rights shall not be construed as a waiver of such rights. The Commission shall not be liable for any delay or failure to perform of its obligations if the delay or failure results from events or circumstances outside its reasonable control, including but not limited to acts of God, strikes, lock outs, accidents, war, fire, failure of communications, telecommunications or computer system, breakdown of plant or machinery or shortage or unavailability of raw materials or products from a natural source of supply, and Industrial Scripts shall be entitled to a reasonable extension of time for the performance of its obligations.
16. You understand that whenever the "Commission/WE/Our/Us" is used above, it refers to (1) the Dubai Film and Television Commission, (2) any entity affiliated with the Commission by way of common ownership or

otherwise, (3) Commission subsidiaries, (4) subsidiaries of such affiliated companies (5) clients of any subsidiary or affiliated company of the Commission, and (6) the officers, agents, employees, stockholders, members, clients, successors and assigns of the Commission. References to “You” throughout this Agreement, shall mean the submitting party including its officers, agents, successors and assigns jointly and severally.

17. Should any provision or part of any provision be void or unenforceable, such provision or part thereof shall be deemed omitted, and this Agreement, Waiver and Release with such provision or part thereof shall remain in full force and effect.
18. You further covenants and agrees that this Agreement, shall be construed in accordance with the laws of the Emirate of Dubai and that any mediation, suit or other proceeding relating to this Agreement, and any activities covered hereby must be filed or entered into only in the Courts of Dubai.
